



**James and Joanne Mitchell** resigned as cleaners for the Town Office.  
**Roy said** he knows of someone who may be interested in doing the cleaning.

**Helen Watts** asked how zoning is coming along, in particular about business zoning. She said the planning board had a person who wanted to do retail sales from her home and was hoping to be open for Mother's day.

**The Selectmen** asked Carol to notify the plowers and road commissioner to come in on June 7th to talk to the Selectmen before we send out requests for bids on the contracts.

**6:53 PM** Roy made a motion to go into Executive Session under 1 MRSA Section 402 (3)(B) privileged against discovery. Marc seconded, vote was 3-0 in favor.

**6:55 PM** Executive Session was adjourned.

**Roy made a motion** to authorize Clyde to call Brunswick Lock and Key to change the combination on the lock on the door to the Town office. Marc seconded. Vote was 3-0 in favor.

**Andrea Murillo and Joseph Thibodeau** brought in receipts which they said proved the taxes were paid for map 7 lot 12 for 2009. The receipts they showed the Board were receipt # 7474 which paid 2006 taxes, # 7106 which paid 2007 taxes, and 9689 which paid 2008 taxes. Carol gave Andrea a copy of the computer printout which shows how these payments were applied. Andrea then showed the Selectmen a pink cashier's check copy which was made out to Town of Bowdoin Taxes and dated April 28, 2009, in the amount of 1200.00, which she said was to pay 2009 taxes. Roy asked why they would pay \$1200.00 on a tax for 2009 when that tax bill was not even out yet. (The tax was committed on 7/31/09). Joseph said he was paying the taxes ahead on map 7 lot 12 and on map 7 lot 6. (They have not been billed for map 7 lot 6 since 2003, this property was tax acquired.) The Selectmen asked if the Town could photocopy the \$1200.00 check. Andrea said no. Mark, the person who was with Andrea and Joseph, said he was with Joseph when he gave the \$1200.00 check to George Bernier and told George he was paying the taxes on both properties. Andrea read the check number to Carol and it is here recorded as 10057203-0. The check is from TD Bank North. The Selectmen will research this.

Joseph said he will be having some questions on map 7 lot 6 too.

**Adjournment:**

Roy made a motion to adjourn at 7:18 PM, John seconded, the vote was 3-0 in favor and meeting adjourned.
